## Delhi Police seizes 640 kg firecrackers from 3 different areas

Delhi Police has seized over 640 kilogram of firecrackers from three different areas in north Delhi, following the Supreme Court order on sale of old firecrackers, an official said Sunday. According to police, 625 kilogram of firecrackers were seized from Sadar Bazar, 11.1 kg firecrackers and 7.9 kg firecrackers were seized by teams from Subzi Mandi and Burari police stations. On

November 3, while head constable Sandeep Chawla was on patrolling duty, he received information about fire crackers/explosive items being stored at a shop opposite Qutub Road Parking, in Sadar Bazar, said Deputy Commissioner of Police (north) Nupur Prasad. Based on this information, a raid was conducted, she added. During checking, the shop was found stocked with fire crackers/

explosive items weighing 625 kilogram. Ravinder (35), a resident of Laxmi Nagar, was found to be storing the firecrackers. A case has been registered and investigation is going on to trace the source of the recovered firecrackers/explosive items, the official added. Apart from this, 11.1kg firecrackers and 7.9 kg firecrackers were seized by Subzi Mandi and Burari police stations, she said.

## Signature Bridge inaugurated, opens to public tomorrow

Delhi chief minister Arvind Kejriwal on Sunday inaugurated the much awaited Signature bridge over Yamuna river in Delhi, connecting the north and northeast parts of the city. The Signature Bridge is an eight-lane carriageway connecting Outer Ring Road and Wazirabad Road which reduces travel time for those going towards Ghaziabad side by more than 30 minutes. The bridge boasts of 127 strands of back-stay cables, spherical bearings of 17,300 tonne vertical capacity, pendulum bearing to resist uplift of 6,300 tonnes, and transportation and handling

of 460 tonne pylon base segment and is being projected as India's first asymmetrical cable-stayed bridge, with the gesture 'namaste'.

The bridge will have a 154-metre-high glass viewing box, which is at double the height of Qutub Minar. According to deputy chief minister Manish Sisodia, who described it as a "civil engineering spectacle", people can enjoy a panoramic view of the city from there, as in the Eiffel Tower in Paris. Announced in 2004, the bridge was initially estimated to cost around

Rs 494 crore. Later, it was projected to be completed at a modified estimate of Rs 1,131 crore ahead of the 2010 Commonwealth Games, which were held in Delhi. The bridge will be thrown open for public from Monday.

## Ram temple in Ayodhya not for holy men, but for people: Sri Sri Ravi Shankar bats for mandir

Religious leader Sri Sri Ravi Shankar on Sunday batted for the construction of the Ram Temple in Ayodhya, and for the Supreme Court to review its Sabarimala verdict. While addressing his followers at Sant Sammelan in New Delhi, the Art of Living Founder said that the Ram Temple was not for the saints, but was for the people of India. "A grand temple must be built in Ayodhya," he said. He also said that the Supreme Court should review its Sabarimala verdict. In

a veiled reference to the ongoing Ram Mandir-Babri Masjid case, Uttar Pradesh Chief Minister Yogi Adityanath on Sunday asserted that work for a Ram Temple in Ayodhya will start soon. "Light a Diya for Lord Ram this time, work there (Ayodhya) will start very soon. We have to take this up after Diwali," Yogi Adityanath said. He was speaking at an event in Bikaner. His statement comes amid reports that the Chief Minister is likely to announce a 151-metre tall statue of Lord Ram on the banks of Sarayu in Ayodhya. Meanwhile, With the Lord Ayyappa temple at Sabarimala set to

open for monthly poojas on November 5, the police is on high alert and tight security arrangements are in place in the backdrop of violent protests over entry of women of menstrual age last month.

## BSF jawan arrested...

Police have filed charges under him under the Official Secrets Act, 1923 and National Security Act 1980. Currently, Riyaz is being interrogated by the police. He is an operator in the BSF as per the complaint filed by the Deputy Commander. He used social media platforms like Facebook Messenger from his phone to give confidential information to his Pak handler Mirza Faisal. The information ranged from details regarding fencing wire on the border, footage of the streets, contact number of officers etc. The Madmot police based on complaint have started probe against him and has taken him into custody after getting remand from the court.

## Light diya for...

"The place where the statue will be installed will be finalised after the soil is tested.

The statue is likely to come up in the vicinity of Sant Tulsidas Ghat. Officials are looking at two-three sites, after which they will pick the best one," Upadhyay, a BJP leader, added. On Friday, UP BJP chief Mahendra Nath Pandey claimed that the Yogi Adityanath has a plan for the Ayodhya issue and the same would be revealed around Diwali. Deputy Chief Minister Keshav Prasad Maurya on Saturday said that nobody can stop the state government from erecting a statue of Lord Ram in Ayodhya. He said that the city belongs to Lord Ram and nothing in the name of Babar will be built there.

## Don't allow people...

He added that the Vedas, in certain circumstances, allowed couples to have 10 children but since India's population had crossed 125 crore, having so many progeny wasn't required any more. Yoga guru Ramdev made a strong pitch for constructing a Ram temple in Ayodhya Saturday, saying a legislation should be brought in Parliament if the Supreme Court does not deliver a verdict on the matter soon. On October 29, the Supreme Court declined an urgent hearing of the Ayodhya land dispute case. It said an "appropriate bench" will decide in January when to hear the politically-sensitive case, sparking demands for a law to begin construction of a Ram temple at the disputed site. The Congress and Muslim groups have said they would want all stakeholders to wait for the apex court verdict, and not rush to resolve the issue through a legislation. Ramdev said there could be sections averse to bringing a legislation for the construction of a temple in Ayodhya but there was no opposition to Ram in India. "If the apex court does not take a decision on the matter soon, then Parliament is the highest institution in a democracy and there is nothing wrong in bringing a legislation," Ramdev told reporters on the sidelines of a two-day conference at Patanjali Yogpeeth.

## Maneka lashes out...

She said she is going to take up the matter 'very strongly' with Maharashtra Chief Minister Devendra Fadnavis. 'I am definitely going to take up this case of utter lack of empathy for animals as a test case. Legally, criminally as well as politically,' she said. She also came down heavily on Mungantiwar for giving order to private marksman Shafat Ali Khan's son to carry out the hunting operation. 'Every time he has used Hyderabad-based shooter Shafat Ali Khan, and this time his son has also appeared in the scene illegally to murder the tigress,' she said in a tweet. 'His son was not authorised to kill. This is patently illegal. Despite the forest officials being committed to tranquillise, capture and quarantine the tigress, the trigger-happy shooter has killed her on his own under orders of Mungantiwar,' she tweeted. 'Shafat Ali Khan has killed 3 tigers, at least 10 leopards, a few elephants and 300 wild boar in Chandrapur, Maharashtra. He is a criminal known for supplying guns to anti-nationals and for a suspected case of murder in Hyderabad,' she said in another tweet. She questioned Maharashtra government's decision to take services of Khan and his son. 'I fail to understand why a state government should even bother about such a man let alone hire his services for illegal and inhuman acts,' she said. Gandhi also expressed concern over the well being of the two cubs left behind after the killing of their mother.

## Temple to be opened...

Comprehensive traffic arrangements have been made by police in Pathnamthitta district where the shrine is located. Private vehicles carrying pilgrims would be allowed to proceed only up to Nilackal, a base camp, police said. The Kerala police has introduced online booking for pilgrims, which would enable them to conveniently choose the day and time of darshan. According to officials, Kerala State Road Transport Corporation tickets are compulsory for all pilgrims, who reach Nilackal, except those who go by foot. The devotees can avail the ticket booking facility and choose the darshan time also. The KSRTC has also made arrangements for the pilgrims who reach for darshan on foot, to avail online tickets from Pamba at the foothills. Meanwhile, the state government said it was prepared to hold talks with the Nair Service Society (NSS), an outfit of the influential Nair community, which is against entry of young women into the hill shrine. "The government is prepared to remove misunderstandings with NSS and has an open mind for talks with the outfit," Devaswom (temple administration) minister Kadakkampally Surendran told reporters. The attack against the NSS office here Friday was "well-planned," he said. BJP leader K Surendran alleged that government had some "hidden agenda" on Sabarimala temple. He said the party's state president, P S Sreedharan Pillai, has received a "death threat" Saturday through speed post and the DGP has been informed. BJP and various Hindu outfits are on the warpath against the left government over its decision to implement the Supreme Court verdict allowing women of menstrual age to enter the shrine.
