Police have filed charges under him under the Official Secrets Act, 1923 and National Security Act 1980. Currently, Riyaz is being interrogated by the police. He is an operator in the BSF as per the complaint filed by the Deputy Commander. He used social media platforms like Facebook Messanger from his phone to give confidential information to his Pak handler Mirza Faisal. The information ranged from details regarding fencing wire on the border, footage of the streets, contact number of officers etc. The Madmot police based on complaint have started probe against him and has taken him into custody after getting remand from the court.

On Friday, UP BJP chief Mahendra Nath Pandey claimed that the Yogi Adityanath has a plan for the Ayodhya issue and the same would be revealed around Diwali. Deputy Chief Minister Keshav Prasad Maurya on Saturday said that nobody can stop the state government from erecting a statue of Lord Ram in Ayodhya. He said that the city belongs to Lord Ram and nothing in the name of Babar will be built there.

Don't allow people...

He added that the Vedas, in certain circumstances, allowed couples to have 10 children but since India's population had crossed 125 crore, having so many progeny wasn't required any more. Yoga guru Ramdev made a strong pitch for constructing a Ram temple in Ayodhya Saturday, saying a legislation should be brought in Parliament if the Supreme Court does not deliver a verdict on the matter soon. On October 29, the Supreme Court declined an urgent hearing of the Ayodhya land dispute case. It said an "appropriate bench" will decide in January when to hear the politically-sensitive case, sparking demands for a law to begin construction of a Ram temple at the disputed site. The Congress and Muslim groups have said they would want all stakeholders to wait for the apex court verdict, and not rush to resolve the issue through a legislation. Ramdev said there could be sections averse to bringing a legislation for the construction of a temple in Ayodhya but there was no opposition to Ram in India. "If the apex court does not take a decision on the matter soon, then Parliament is the highest institution in a democracy and there is nothing wrong in bringing a legislation," Ramdev told reporters on the sidelines of a two-day conference at Patanjali Yogpeeth.

Maneka lashes out...

She said she is going to take up the matter very strongly' with Maharashtra Chief Minister Devendra Fadnavis. 'I am definitely going to take up this case of utter lack of empathy for animals as a test case. Legally, criminally as well as politically,' she said. She also came down heavily on Mungantiwar for giving order to private marksman Shafat Ali Khan's son to carry out the hunting operation. 'Every time he has used Hyderabad-based shooter Shafat Ali Khan, and this time his son has also appeared in the scene illegally to murder the tigress,' she said in a tweet. 'His son was not authorised to kill. This is patently illegal. Despite the forest officials being committed to tranquilise, capture and qurantine the tigress, the trigger-happy shooter has killed her on his own under orders of Mungantiwar,' she tweeted. 'Shafat Ali Khan has killed 3 tigers, at least 10 leopards, a few elephants and 300 wild boar in Chandrapur, Maharashtra. He is a criminal known for supplying guns to anti-nationals and for a suspected case of murder in Hyderabad,' she said in another tweet. She questioned Maharastra government's decision to take services of Khan and his son. 'I fail to understand why a state government should even bother about such a man let alone hire his services for illegal and inhuman acts,' she said. Gandhi also expressed concern over the well being of the two cubs left behind after the killing of their mother.

Temple to be opened... Comprehensive traffic arrangements have been

Meanwhile, the state government said it was prepared to hold talks with the Nair Service Society (NSS), an outfit of the influential Nair community, which is against entry of young women into the hill shrine."The government is prepared to removemisunderstandings with NSS and has an open mind for talks with the outfit," Devaswom (temple administration) minister Kadakkampally Surendran told reporters. The attack against the NSS office here Friday was "well-planned," he said. BJP leader K Surendran alleged that government had some "hidden agenda" on Sabarimala temple.He said the party's state president, P S Sreedharan Pillai, has received a "death threat" Saturday through speed post and the DGP has been informed.BJP and various Hindu outfits are on the warpath against the left government over its decision to implement the Supreme Court verdict allowing women of menstrual age to enter the shrine.
