Enforcement Directorate arrests CAP daughter Misa Bharti in money laundering case

New Delhi: The Enforcement Directorate on Tuesday arrested the chartered accountant of RJD chief Lalu Prasad's daughter Misa Bharti in connection with an alleged money laundering case. An ED official told IANS that Rajesh Agarwal was arrested from Delhi for alleged money laundering and involvement in the black money racket.

Agarwal was accused of converting black money through dubious transactions with the help of two brothers S.K. Jain and V.K. Jain. The ED had arrested the Jain brothers on March 20. At least 90 shell firms were under the ED scanner. Agarwal has also been accused of helping Bharti's husband's company, Mishail Packers and Printers Pvt Ltd.
