**मुंबई, दि. ५ :** राज्यात ४५ लाख कुटुंबांकडे गॅस जोडणी नाही त्यांना गणेशोत्सवापूर्वी गॅस जोडणी देऊन अवघा महाराष्ट्र चुलमुक्त करणार असल्याची माहिती, अर्थ मंत्री सुधीर ामट, गुंगटीवार यांनी दिली. सहाद्री अतिथीगृहात झालेल्या बैठकीत ते बोलत होते. यावेळी अन्न व नागरी पुरवठा मंत्री गिरीश बापट, विभागाचे प्रधान सचिव महेश पाटक, चंद्रपूर चे जिल्हाधिकारी कुणाल खेमणार यांच्यासह सर्व संबंधित अधिकारी उपस्थित होते.

मुख्य सचिवांनी या संदर्भात सर्व संबंधितांची बैठक घ्यावी अशा सूचना देऊन श्री. म गुंगटीवार म्हणाले, चुलीच्या धुरापासून महिलांच्या डोळ्यांना होणारा त्रास थांबविण्यासाठी

प्रधानमंत्री उज्वला योजना देशभर राबविली जात आहे. या योजनेतर्गत महाराष्ट्रात ज्या लाभार्थ्यांना गॅस जोडणी देणे शक्य आहे त्यांची यादी तयार करण्यात यावी. उर्वरित जे लाभार्थी उज्वला योजनेत लाभ घेऊ शकत नाहीत त्यांना गॅस जोडणी देण्यासाठी राज्य शासन निधी उपलब्ध करून देईन. अन्न व नागरी पुरवठा विभागाने याचा सविस्तर अभ्यास करून लागणाऱ्या निधीचा प्रस्ताव वित्त विभागाकडे सादर करावा, त्यास मंजुरी दिली जाईल. अर्थमंत्र्यांनी याच बैठकीत बल्लारपूर विधानसभा क्षेत्रातील गॅस जोडणीचा ही आढावा घेतला. या क्षेत्रात गॅस नसलेल्या शिधापत्रिकांची संख्या ११ हजार ८३ इतकी आहे. जिल्हाधिकारी

# राज्यात मागील वर्षी ३0 हजार रस्ते अपघातात 9३ हजार मृत्यू

**मुंबई, दि. ५ :** राज्यात वाहनांची संख्या ही ३ कोटी २९ लाख इतकी झाली आहे. त्यामध्ये दुचाकी वाहनांची संख्या अधिक आहे. राज्यात मागील वर्षी जवळपास ३० हजार रस्ते अपघात झाले, त्यामध्ये १३ हजार जणांना आपले प्राण गमवावे लागले. यापैकी सुमारे ११ हजार मृत्यू म्हणजे ८० टक्के मृत्यू हे मानवी

चुकांमुळे झाल्याचे समोर आले आहे. अपघातांची आणि त्यातून होणारी मनुष्यबळाची हानी फार गंभीर आहे. अनेक ठिकाणी वाहतुकीतील बेदरकारपणा दिसत असून त्यातूनही अनेकांना प्राणास मुकावे लागत आहे. हे रोखण्यासाठी सर्वांनी रस्ते सुरक्षेबाबत जाणीव ठेवून वाहतुकीच्या नियमांचे काटेकोर पालन करावे, असे आवाहन

परिवहन मंत्री तथा राज्य रस्ता सुरक्षा परिषदेचे अध्यक्ष दिवाकर रावते यांनी केले. परिवहन विभाग आणि वाहतूक पोलीस शाखेमार्फत राज्यभरात ४ ते १० फेब्रुवारी दरम्यान रस्ता सुरक्षा सप्ताह आयोजित करण्यात आला आहे. आज येथील यशवंतराव चव्हाण प्रतिष्ठान येथे मंत्री रावते यांच्या हस्ते या अभियानाचा शुभारंभ करण्यात

आला. त्यावेळी ते बोलत होते. मंत्री रावते म्हणाले की, राज्यात २०१६ मध्ये १२ हजार ९३५, २०१७ मध्ये १२ हजार ५११ तर २०१८ मध्ये १३ हजार ५९ अपघाती मृत्यू झाले. वाहनांच्या वेगाबरोबर अपघातांची आणि त्यातील मृत्यूंची संख्या वाढत आहे. मुंबई पुणे एक्सप्रेस वे हा तर अती वेगामुळे मृत्यूचा सापळा झाला आहे. सुरक्षेच्या दृष्टीने

दुचाकी चालकांनी हेल्मेट वापरणे आवश्यक व कायदेशीरदृष्ट्या अनिवार्य आहे. पण शासनाने हेल्मेटची सक्ती केली, असे म्हणत या चांगल्या मोहिमेबाबत अपप्रचार केला जात आहे. वृत्तपत्रांनीही या मोहीमेला सक्ती असे न म्हणता हेल्मेटच्या आवश्यकतेबाबत जनजागृती करावी, असे आवाहन त्यांनी यावेळी केले.
